# **ISSUE STATEMENT**

Mark Gissiner was hired as the City of Eugene Police Auditor on June 29, 2009. This agenda item is for the council to conduct Police Auditor Gissiner's annual performance review. The two-part format includes an executive session followed by a public session. During these sessions councilors will review the results of the gathered feedback, share their overall performance feedback, and discuss any compensation adjustments.

### **BACKGROUND**

The evaluation process includes the results of feedback solicited from the Civilian Review Board (CRB) by Mr. Gissiner, a summary of feedback collected in a survey from a list of citizens, and a self evaluation submitted by Mr. Gissiner. A summary of this feedback and the Police Auditor's self evaluation were sent to the council in advance of this work session. City Councilors were also asked to fill out their own performance dimension forms in rating Mr. Gissiner's performance.

Human Resource staff has compiled all of this information to support the City Council in getting a well-rounded view of the performance of the Police Auditor this year.

For background information regarding the compensation portion of the discussion, Human Resources has conducted a market survey each year regarding the Police Auditor position salary. A summary of that data is included with the feedback summaries.

The contract with Police Auditor Gissiner provides that with respect to an annual Cost of Living Adjustment (COLA) "the City Council will consider cost of living adjustments for Gissiner at the same time that other exempt employees receive cost of living adjustments." Any COLA for the Police Auditor should be deferred until such time that a decision is made about non-represented exempt employees receiving a COLA.

# RELATED CITY POLICIES

The City Council conducts an annual performance review of the Police Auditor, aligned with their desire to offer formal feedback.

# **ISSUE STATEMENT**

This item is a follow-up work session on the topic of homeless camping. It is intended to provide additional information as requested subsequent to the May 20, 2013, work session on the same topic.

# **BACKGROUND**

The City Council held work sessions on homeless camping in parks and open spaces on April 24, 2013, and May 20, 2013, and has previously been provided the following options to consider:

- (1) Eugene Code section 4.816(1) authorizes a business, religious institution or public entity to allow up to three vehicles at a time to use its parking lot for camping/sleeping (subject to certain requirements, including that the entity provide garbage disposal services, sanitary facilities and storage for personal items). The council has expanded "vehicles" to include tents and Conestoga huts. The council could direct the City Manager to bring back an ordinance to expand the number of vehicles (tents and Conestoga huts) from three to five or six.
- (2) The council could direct the City Manager to bring back an ordinance that would allow a religious institution or other non-profit to permit dusk-to-dawn camping at its facility for up to some number of campers (perhaps five) and to explore creating a network to allow individuals to easily identify places where they could camp.
- (3) The council could direct the City Manager to bring back an ordinance removing the sunset on the Conestoga hut ordinance, or alternatively, extending the sunset for two years.

On April 24, 2013, the City Council passed the following motion modifying the second option:

"Direct the City Manager to bring back an ordinance that would allow people to sleep undisturbed and camp overnight from 10:00 p.m. to 7:00 a.m. on vacant City of Eugene owned lands, but not including improved park land or sensitive environment open spaces, with staff to bring back a specific list of allowable sites, and on religious institution, non-

profit organization, commercial and industrial properties if they allow it. This shall be a pilot program for 120 days and council shall then review the pilot program and assess whether or not to continue the ordinance."

The attached draft ordinance (Attachment A) was included with the agenda item summary (AIS) materials for the May 20 work session and incorporates each of these options. The draft ordinance is annotated with comments that explain the ordinance's provisions and how the provisions address the three options. At the most recent work session, the council offered a number of questions and comments including several modifications to the site criteria, the scope of work, liability, community partnerships, and other related issues. It is not clear where consensus lies with regard to any of the discussion topics; an attempt has been made to provide updated materials that best reflect the discussion to this point.

<u>Sites</u> – Attachment B is a refreshed list of potential homeless camping sites representing undeveloped City-owned properties and for which the criteria for inclusion on the updated list is more specifically described on the attachment. Note there are a total of 20 sites including 11 undeveloped parks and nine properties that are not part of the parks inventory. Attachments C thru F are maps that depict the sites graphically.

<u>Scope of Work</u> – There has been considerable discussion around various pilot programs but less clarity on the specific desired outcomes. Council guidance on a number of specific questions would assist with defining the actual scope of work. In particular, this conversation began with a suggestion to consider amending the camping ordinance to allow dusk-to-dawn camping in City parks. There has subsequently been discussion of the concept of "rest stops," hosted semi-permanent facilities, and more substantial accommodations than initially contemplated. Some specific questions for council deliberation might include:

- 1. Should one or more sleep sites be established? If so, should these be in parks, other City properties, both, neither?
- 2. What are the site criteria?
- 3. Should the sites be hosted or otherwise managed and should tenants be screened for compatibility?
- 4. What amenities should be provided? Restrooms? Garbage collection? Storage lockers? Other?
- 5. How should neighborhoods be involved in siting decisions?
- 6. What are the desired outcomes in terms of number of campers per site, hours of operation, cleanup, behaviors, etc.?

<u>Liability</u> – Some of the councilors as well as the SLEEPS advocates have asked questions related to liability. The City Attorney suggests that many of the options that have been discussed might increase the potential liability of and risk to the City, but generally, there are ways to mitigate the risk so that the risk is no greater than for many of the City's other programs. It is difficult to identify the potential risk for all of the different ways in which a program can be structured as the details could make a difference. The City Attorney's office recommends that the council identify the specific programs or outcomes that – as a policy matter – it would like to pursue. The City

Attorney's office can provide the council with both an assessment of the risk for those specific proposals, and if the risk is significant, with possible options to reduce the risk.

<u>Community Partnerships</u> – Some councilors have mentioned a collaborative approach with the community in working the issue where the City would, for example, assume a support role to the non-profit and/or for-profit social services network. Attachment G is a current list maintained by Eugene Police of community social services agencies. There are 12 agencies listed as providing shelter which could provide the council a starting point for a gap analysis. This approach could also take advantage of the professional management services these agencies provide in addressing the homeless issues in Eugene.

# **COUNCIL OPTIONS**

The council options include:

- 1. Direct the City Manager to schedule a public hearing on the draft ordinance and the list of potential sites for the pilot program.
- 2. Pursue resolution through a collaborative effort with the local social services network.

# CITY MANAGER'S RECOMMENDATION

The City Manager recommends the City Council take the following actions:

- 1. Provide specific guidance as to the scope of work, problem statement, and desired outcomes.
- 2. To the extent council remains interested in accommodating overnight camping in City parks and other City property, direct the City Manager to schedule a public hearing on the draft ordinance and the list of potential sites for the pilot program.

ORDINANCE N	IO.

AN ORDINANCE CONCERNING PERMITTED OVERNIGHT SLEEPING AND TEMPORARILY AMENDING SECTION 4.816 OF THE EUGENE CODE, 1971; AMENDING ORDINANCE NO. 20503 REGARDING CONESTOGA HUTS; AND PROVIDING A SUNSET DATE.

# The City Council of the City of Eugene finds as follows:

- **A.** Section 4.816 of the Eugene Code, 1971 (EC) provides for the regulation of overnight sleeping.
- **B.** In order to create additional sleeping options for homeless persons, EC 4.816 should be temporarily amended to expand the permitted overnight sleeping provisions as a pilot program until November 1, 2013. The temporary amendment will allow the City to monitor these changes to determine whether they should be made permanent, revised or abandoned.

# NOW, THEREFORE,

# THE CITY OF EUGENE DOES ORDAIN AS FOLLOWS:

- **Section 1**. The findings set forth above are adopted.
- **Section 2.** Subsection (1) of EC 4.816 is amended to provide as follows:

# 4.816 Permitted Overnight Sleeping.

- (1) Notwithstanding any other provision of this code:
  - (a) Persons may sleep overnight in a vehicle[, camper or trailer] in a parking lot of a religious institution, place of worship, business or public entity that owns or leases property on which a parking lot and occupied structure are located, with permission of the property owner. The property owner may not grant permission for more than [three] six vehicles used for sleeping at any one time. For purposes of this subsection (1), the term "vehicle" includes a car, tent, camper, trailer, and Conestoga hut.

[Comment: Each site is currently limited to 3 vehicles. The first proposed change would double the number of vehicles/tents/huts that could be located at each site.

<u>Comment</u>: The second proposed change would allow tents and Conestoga huts to continue until the ordinance sunsets.

- (b) Persons may sleep overnight in the back yard of a single family residence in a residential zoning district, with permission of the owner and tenant of the residence. Not more than one family may sleep in any back yard, and not more than one tent or camping shelter may be used for sleeping in the back yard. As an alternative, but not in addition to sleeping overnight in the back yard, not more than one family may sleep in a vehicle, camper or trailer parked in the driveway of a single family residence in a residential zoning district, with permission of the owner and tenant of the residence. For purposes of this subsection, "family" means persons related by blood or marriage, or no more than two unrelated adults.
- (c) Persons may sleep overnight in a vehicle, [camper or trailer] on a paved or graveled surface located on a vacant or unoccupied parcel, with the permission of the property owner, if the owner registers the site with the city or its agent. The city may require the site to be part of a supervised program operated by the city or its agent. The property owner may not grant permission for more than [three] six vehicles used for sleeping at any one time.
- (d) The following entities may allow not more than ten persons to sleep overnight, between 9:00 p.m. and 7:00 a.m. only, on property owned by the entity, or, if leased by the entity, with permission of the owner: the City of Eugene; a religious institution; a non-profit organization; and a business if the business is located on property zoned commercial or industrial. No more than five vehicles may be used for overnight sleeping at any one site under this provision.

[Comment: This proposed change would allow "dusk-to-dawn" camping on sites to be designated by the City, as well as sites authorized by a religious institution, a non-profit organization, and a business as long as the business is located in a commercial or industrial zone.

<u>Comment</u>: The section proposes to limit the number of persons at any one site to ten persons, and to limit the number of vehicles to five vehicles. At the last work session, Council did not specify a limit on persons or vehicles at any one site. Staff recommends that there be a limit, especially for this pilot period, to reduce the likelihood of adverse effects to neighboring properties.]

1. After 7:00 a.m. at a location where overnight sleeping has occurred as allowed under this subsection (1)(d), a person who used the site for overnight sleeping shall remove all personal property from the site.

[Comment: This subsection would require that anyone sleeping overnight remove all of his or her

belongings at "dawn" so that the site does not become a 24-hour site that would fall under subsection (1)(a) (requiring trash and sanitary facilities).]

2. An entity that allows overnight sleeping on its property pursuant to this subsection (1)(d) shall takes steps to prevent the overnight sleeping from interfering with the use and enjoyment of nearby properties, but the entity is not required to provide the services or facilities described in EC 4.816(2)(a)(b)and (c).

[Comment: This subsection would require the owner/tenant of the property who allows the "dusk-to-dawn" camping to ensure that the individuals who are camping do not interfere with the use or enjoyment of the neighboring properties.]

3. At any time the city manager determines that, at a specific site, the overnight sleeping authorized by this subsection (1)(d) is causing substantial interference with the use and enjoyment of nearby property, the city manager may suspend or revoke the entity's ability to allow overnight sleeping at that site. The city manager may provide that the suspension or revocation will take effect immediately or upon such notice as the manager deems appropriate in light of the circumstances. A suspension may provide that permission for overnight sleeping will be restored when the property owner meets certain conditions to prevent further interference with the use and enjoyment of nearby properties.

[Comment: This subsection would give the manager the authority to prohibit dusk-to-dawn camping on a specific piece of property if the camping is substantially interfering with the use or enjoyment of neighboring properties.]

**Section 3.** The City Manager is directed to designate, by administrative order, up to eight sites on vacant city-owned property for purposes of the camping described in EC 4.816(1)(d).

[Comment: This section would require the city manager to identify up to 8 city-owned sites where dusk-to-dawn camping could occur. If there is a problem at one of the sites, the manager would be able to terminate the camping at that site, and then identify another site.]

Section 4. Section 5 of Ordinance 20503, pertaining to Conestoga huts, is amended to

extend the sunset date to November 1, 2013.

[Comment: This section would extend the sunset for Conestoga huts to match up with the sunset for this new pilot.]

<u>Section 5</u>. Unless extended or made permanent by future Council action, this Ordinance shall sunset and be repealed on November 1, 2013.

[Comment: This section would sunset this pilot program on November 1, 2013, unless the council extended the sunset date.]

Subject: Potential Homeless Camping Sites Criteria

This memo documents criteria and methods used by staff to identify potential homeless camping sites in Eugene. These criteria were developed and refined based on prior work sessions with the City Council. Staff has prepared maps and a listing of sites which meet these criteria. For a site to be included in the maps and lists it was determined to meet the following criteria:

- City-owned (excluding EWEB-owned sites that name the City as an owner)
- Non-sensitive open space (exclude ridgeline, Goal 5, wetlands, Willamette R., Amazon Cr)
- Street access
- Within city limits
- Greater than one tenth of an acre in size
- Relatively flat
- Useable shape (e.g. not long and narrow)
- Not heavily wooded
- Undeveloped and excluding utilities (pump stations and drainageways)

Application of these criteria resulted in the following identified potential sites:






