ISSUE STATEMENT

Jon Ruiz was hired as the Eugene City Manager on April 14, 2008. This agenda item is for the council to conduct City Manager Ruiz's annual performance review. The two-part format agreed upon by the council and City Manager Ruiz includes an executive session followed by a public session. During the executive session, councilors will review the results of the feedback gathered, share their overall performance feedback, and discuss final comments. Based on the discussion, the City Manager will submit his proposed goals for the coming year to the council.

BACKGROUND

This year's feedback process includes a couple of key questions, framed from the agreed-upon performance dimensions, which were sent to the executive leaders of each City department, other City employees who had worked on projects with the City Manager, union leadership and an identified group of community leaders. City Councilors also are completing their own evaluation forms. A summary of this feedback and the City Manager's self-evaluation are being sent to the council in advance of this work session.

Human Resources is compiling this information to support the City Council in getting a wellrounded view of the performance of the City Manager this past year. Human Resources will also calculate the compensation adjustment based on the City Manager contract language. With respect to compensation, the contract provides that the City Manager will receive (1) whatever COLA non-represented employees receive, and (2) a merit and deferred compensation adjustment based on the ratings that the council gives to the City Manager, "unless the council determines that the City's budget situation is sufficiently ominous that no merit or deferred compensation increase should be made." The calculation related to any compensation adjustment will be included in the notebook containing the evaluation forms and summaries that will be provided to each elected official.

RELATED CITY POLICIES

The City Council has historically conducted an annual performance review of the City Manager.

ISSUE STATEMENT

This work session will provide an update on revisions to the Bethel Community Park Master Plan completed in 2012 that enable a new YMCA community center facility to be constructed in the park. No action is being requested of the council at this time.

BACKGROUND

The Eugene Family YMCA approached the City of Eugene Parks and Open Space (POS) Division and the Recreation Division in 2009 with a proposal to expand their services in the Bethel area by building and operating a new facility in Bethel Community Park. Because this area did not have a community center or recreation services to meet the growing needs of the area, and the City did not have sufficient resources to offer comparable services to that area in the foreseeable future, the Parks and Open Space and Recreation divisions felt the proposal merited consideration. As a result, POS agreed to conduct a park planning process to evaluate the proposal and involve the community in reviewing options for amending the master plan for the park. POS held a series of four public meetings and four web-based surveys to gather public feedback from more than 650 community members.

The original Master Plan for Bethel Community Park included a future community center of approximately 10,000 square feet. While this is an average size for City-run community centers that typically serve specific user groups (seniors, children, families, etc.), a full-service community center like a YMCA would require closer to 65,000 square feet and a significant additional number of parking spaces to accommodate all users. The larger building size and additional parking necessitated revisions to the master plan for the park.

Based on extensive community input, a revised master plan was approved by the Parks and Open Space Division in January of 2012, which provides a site adequate for the YMCA facility on the west side of the park, next to Legacy Street (see diagram, Attachment A). Additional information regarding the master plan revisions and the public involvement process is available on the project website at www.eugene-or.gov/bethelpark.

Future development in Bethel Community Park must also comply with a Conditional Use Permit

(CUP) currently on file with the City Planning and Development Department. Including a relocated, larger community center in the park will require either a modification of the existing CUP approval or a new CUP approval. Parks and Open Space staff will work with the Eugene Family YMCA and their contractors to update the existing CUP consistent with changes in the updated park master plan. Prior to embarking on the land use approval process, and assuming the substantial costs associated with that process, the Y has asked the City to enter into a long-term agreement to lease the identified site to be used for the Y facility. The lease will be the topic of a future council work session.

RELATED CITY POLICIES

The Parks, Recreation and Open Space Project and Priority Plan, adopted by the council in May 2006, lists the following as a Priority 5 project: "Provide major community center on west side of Beltline to serve Bethel." Priority 5 projects were defined as "projects that realize the community's long range vision for parks, open space, recreation programs and services, but are not anticipated to be completed within the next 20 years."

The Council's goal of "Effective, Accountable Municipal Government" and the related outcome of "Public engagement that involves the community broadly" apply to this project. The Parks and Open Space Division led an extensive public process involving hundreds of community members in making the decision to allow a larger community center in Bethel Park.
