ISSUE STATEMENT

The Pledge of Allegiance to the Flag will be recited in observance of Flag Day which is celebrated on June 14.

BACKGROUND

The City Council voted at its June 27, 2011, work session to begin formal council meetings with a voluntary recitation of the Pledge of Allegiance to the Flag at those meetings closest to the following holidays: Memorial Day, Veterans Day, Flag Day, and the Fourth of July. In addition, the council voted to begin a practice of reading from the Declaration of Independence and/or the Constitution of the United States at the beginning of its meeting closest to the Fourth of July.

According to the United States Code, Title 4 (U.S. Flag Code), the Pledge "...should be rendered by standing at attention and facing the flag with the right hand over the heart. When not in uniform, men should remove any non-religious headwear with their right hand and hold it at the left shoulder, the hand being over the heart. Persons in uniform should remain silent, face the flag, and render the military salute."

The Pledge is as follows: *"I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all."*

Councilor Syrett opened the May 13, 2015, City Council work session, noting that Mayor Piercy was in Salem lobbying on behalf of the City.

Councilor Syrett adjourned the meeting of the Eugene City Council and convened the meeting of the Eugene Urban Renewal Agency.

A. WORK SESSION: Eugene Water & Electric Board Riverfront Redevelopment Project and Riverfront Urban Renewal District Investments

City Engineer Mark Schoening, Community Development Manager Denny Braud, and Economic Development Planner Anne Fifield showed a PowerPoint presentation outlining the strategic investments and triple bottom line analysis of the EWEB riverfront redevelopment project.

Council discussion:

- Concern expressed about closing railroad crossings without having the public weigh-in.
- A TBL analysis on this project is very important.
- Franklin Boulevard is in great shape focus should be on other areas.
- Investing a few million dollars of public money to bring in hundreds of millions of dollars in economic activity is a good idea.
- Early and frequent opportunities for public engagement will be critical to this project's success.
- Concern expressed about spending large amounts of public money without it going to a vote.
- A facility and environmental study of Franklin is required to apply for a TIGER grant.

MOTION AND VOTE: Councilor Evans, seconded by Councilor Zelenka, moved to include the use of \$140,000 of RURD funds for the design of the relocation of the 8th Avenue crossing in the June supplemental budget. **PASSED 7:1**, Councilor Taylor opposed.

MOTION AND VOTE: Councilor Evans, seconded by Councilor Zelenka, moved to include the use of \$100,000 of RURD funds for design of the Quiet Zone in the June supplemental budget. **PASSED 7:1**, Councilor Taylor opposed.

MOTION AND VOTE: Councilor Evans, seconded by Councilor Taylor, moved to approve the River Loans program guidelines. **PASSED 7:1**, Councilor Taylor opposed.

Councilor Syrett adjourned the meeting of the Eugene Urban Renewal Agency and reconvened the meeting of the Eugene City Council.

MOTION AND VOTE: Councilor Evans, seconded by Councilor Taylor, moved to approve the submittal of an STP-U funding appropriation request of \$850,000 for the development of the Franklin Multi-Way Boulevard facility plan and environmental studies with the intention to use

Item 3.A.

RURD funds of \$95,000 for the grant match. **PASSED 7:1**, Councilor Brown opposed.

A. WORK SESSION: City and Lane Regional Air Protection Agency Partnership

Assistant City Manager Sarah Medary gave an update on new safe demolition practices. LRAPA Director Merlyn Hough showed a PowerPoint presentation outlining the history of LRAPA, its vision, mission, and goals, and data generated from its monitoring work.

Council discussion:

- The safe demolition document is thorough and useful.
- Accountability issues remain.
- Main goal of agency is the protection of citizens' health.

B. WORK SESSION: Healthy Downtown and Public Smoking

Assistant City Manager Sarah Medary and Library, Recreation and Cultural Services Director Renee Grube showed a PowerPoint presentation discussing the background of the healthy downtown and public smoking project, what was learned, considerations and options, and next steps.

Council discussion:

- There is a significant difference between indoor and outdoor smoking; public health vs behavioral issue.
- Need to find alternative way to enforce other than relying on police personnel.
- Smoking is still a legal activity; civil liberties issues are compelling.
- City should be a steward of public health and protect the public with ordinances.
- Other types of smoking, such as smokeless tobacco, should be considered.
- Need to find balance between protecting public health and accommodating those who choose to smoke.
- Designated smoking areas downtown would be needed.

The meeting adjourned at 1:31 p.m.

1. Martin Champion – opposed a ban on smoking in parks and exclusion without due process.
2. Sue Sierralupé – said Occupy Medical is doing good work but needs sharps containers.
3. Alley Valkyrie – opposed a ban on smoking downtown; attempt to push poor people out.
4. Peter Grotticelli – opposed to ban on smoking; community gardens shouldn't be individualized.
5. Terra Williams – opposed to ban on smoking; unfairly targets homeless community.
6. Lorene Hunt – said affordable housing complex is causing parking issues in neighborhood.
7. Art Bollman – opposed segregating classes downtown; trying to push homeless out.
8. Pam Wooddell – opposed to South Willamette rezoning; concerned with process and timeline.
9. Zachary Vishanoff – said efforts to densify neighborhoods have been secretive.

Council discussion:

- Complaints about the public safety system should be directed to the Police Auditor.
- More information on the South Willamette plan requested.
- Purpose of the proposed smoking ban is to protect the public's health; not intended to target the homeless population.
- Suggestion to provide sharps containers in parks is a good one; would create a public health benefit.
