



### Height Limits: Willamette Street at 27th Avenue





 Height limits with existing maximums and proposed






### Height Limits: 29th Avenue at High Street









### Height Limits: Portland Street south of 29th Avenue

Council President Claire Syrett called the May 6, 2015, session of the Eugene City Council to order.

#### A. BOARDS AND COMMISSIONS INTERVIEWS

The council interviewed Scott Nowicki, Lori Mace, and Ted Recio for vacancies on the Budget Committee. Each candidate was asked the following questions:

- 1. What factors do you think are important in assessing the financial health of the City government? How would you describe the difference between a stable budget and a sustainable budget for Eugene?
- 2. Due to limited resources there are many unfunded needs and competing priorities facing the City today. As the economy stabilizes and the city looks towards the future needs of the community what factors should be used to make difficult choices on expanding or adding service areas?
- 3. Are there specific pieces of information that you think would be helpful for the public to understand about the City's financial situation?
- 4. Taking into account that broad community input is an important part of the Budget Committee discussions and decision-making, what types of information and community feedback would you consider as part of analyzing and discussing the City's budget?

The council interviewed Natalie Medina, Heather Marek, and Lindsey Foltz for vacancies on the Civilian Review Board. Each candidate was asked the following questions:

- 1. What can you tell us about your activities, personal attitudes and life experience that would demonstrate you can make objective decisions about complaints against the police?
- 2. What contacts, positive or negative, have you had with police or in the criminal justice system?

3. One of your neighbors is a Eugene officer. He knows you're on the CRB. Recently, he asked you a hypothetical question about what you think an officer should do in a particular situation. What would be your response to his question?

The council interviewed Marcus Baxter and Evan Shenkin for vacancies on the Toxics Board. Each candidate was asked the following questions:

- 1. FOR INDUSTRY POSITION APPLICANT ONLY
  - To be an industry member on the Toxics Board, you must be employed by or be an agent of a company required to report under Eugene's Toxics Right-to-Know Program. Please tell us how you qualify for board membership.
- 2. FOR ADVOCACY POSITION APPLICANT ONLY
  To be an advocacy member on the Toxics Board, you must have a proven record of
  environmental advocacy. Please tell us how you qualify for board membership.
- 3. What is your understanding of the purposes of Eugene's Toxics Right-to-Know Program?
- 4. What is your understanding of how the program functions?
- 5. As a member of the Toxics Board, what improvements would you like to make? What problems would you like to solve?
- 6. Do you feel that you can work effectively with the other members of the board, some of whose viewpoints on certain issues may be diametrically opposed to yours? Why?

Can you comment on your experiences and/or your interest in addressing these issues?
- 4. What do you see as the most important human rights issues in our community now? What are some solutions you think will help resolve those issues?

The council interviewed Brianna Nicolello, William Randall, and Marshall Wilde for vacancies on the Planning Commission. Each candidate was asked the following questions:

- 1. What key issues would you hope to address as a member of the Planning Commission?
- 2. The Eugene Planning Commission often works on lengthy processes and decisions as a group. Describe your prior skills and experience that will assist you in working with the Planning commission in a collective manner.

- 3. The Planning Commission meets most Mondays from 11:30-1:30, and sometimes on Tuesday evenings. There is often a high volume of materials to review and consider between meetings. Do you have the time and flexibility in your schedule to accommodate this level of commitment?
- 4. Please describe how you would contribute to the diversity of views on the Planning Commission. In what ways would you seek to bring the perspectives of underrepresented members of our community into the land use planning and decision process?
- 5. The Planning Commission must often consider and balance complex issues when reviewing planning documents and making land use decisions. As an example, through Envision Eugene, the city is in the process of implementing strategies to accommodate 34,000 new residents over the next 20 years. In your opinion, what are the most important factors for the Planning Commission to consider in this effort?
