Nothing came to mind when I read your request. Honestly I wondered if there were actually an alley there as I tried to figure out where the railroad tracks were.

I had my data base queried. I asked for all reported crashes at the four intersections of 4th, 5th, Lincoln and Charnelton to bracket the alley. If there were crashes at the alley, the formal report may have tied the location to the nearest intersection. In three years of data I find no crashes connected to either of the 4th intersections. I had a total of nine crashes in 3 years at the two 5th St. intersections. 6 were angle crashes, two rear end and one was turning movement. To have 5 crashes in 3 years (5th and Charnelton), two of which were rear end, is not a hot spot for crashes.

I checked with several staff members and they too are unaware of any historical safety problem or on-going issues we are aware of at the alley.
