# Eugene City Council Meeting Eugene, Oregon 97401

July 10, 2023 7:30 p.m.

Mayor Vinis opened the July 10, 2023, meeting of the Eugene City Council in a hybrid inperson and virtual format at 101 W. 10<sup>th</sup> Avenue, Suite 114, Eugene, OR 97401.

- Councilor Groves noted his appreciation for the firefighters who worked on the Moon Mountain Fire.
- Councilor Keating noted his appreciation for Eugene Springfield Fire and neighboring agencies who worked on the Moon Mountain Fire; noted his appreciation for those who chose not to set off fireworks on the 4<sup>th</sup> of July; noted his recent attendance at the Eugene Chamber of Commerce happy hour at Hayward Field.
- Councilor Zelenka noted his appreciation for Eugene Springfield Fire and neighboring agencies who worked on the Moon Mountain Fire; noted the City may need to change its firefighting strategies over time due to climate change and drought.
- Councilor Groves noted there were fewer calls reporting fireworks this year over last; noted that local fires pose a significant danger every year, but the local force can respond to most reports within minutes, preventing severe outcomes.
