### 1. PLEDGE OF ALLEGIANCE TO THE FLAG

### 2. PUBLIC FORUM

1. Zach Mulholland –voiced Sustainability Commission concerns related to Riverfront Development.

9. Jim Neu – spoke about the projects completed at the UO Climate Change Symposium.

**4. PUBLIC HEARING: An Ordinance Concerning Waiving Off-Street Parking Requirements for the Edison Elementary School Site, and Amending Section 9.6410 of the Eugene Code, 1971. (City File CA 18-2)**

Councilor Clark opened the Public Hearing and asked if any Council member needed to disclose any bias, conflicts of interest, or ex parte contacts.

Council Discussion

- Councilor Zelenka declared that he mentioned the proposed Edison School Parking Ordinance at a meeting of the Local Government Affairs Council of the Eugene Chamber of Commerce, Laurel Hill Valley Citizens meeting, Fairmount Neighborhood meeting, and the Ward 3 candidate forum. It was determined that he did not receive any information outside of the record, and can therefore make an impartial, unbiased decision on Edison School Parking based on applicable approval criteria and the arguments and evidence in the record.
