ISSUE STATEMENT

The purpose of this work session is to discuss the timeline and process for developing a draft sick leave ordinance that the council will consider for adoption.

BACKGROUND

The council has asked staff to move forward with a process to develop a draft ordinance that would establish minimum standards for earned paid sick time for workers within the city limits of Eugene. This effort is similar to legislation that has recently been passed in Portland, Seattle, San Francisco and Washington D.C. During the work session, staff will present a plan for developing a draft ordinance including an approach to community engagement. Some of the key steps include:

- City Council work session (April 9, 2014) (discussion of project plan)
- City Council work session (discussion of draft ordinance prepared by staff)
- Publish draft ordinance for public review (approximately two weeks prior to public hearing)
- City Council public hearing on draft ordinance
- City Council meeting (consider adoption of ordinance)
